- Business Development EXACT training conducted (Review EXACT Background and Purpose)
- Technical EXACT training conducted (Review Screenshot Requirements, System Requirements for UAT Testing, and Additional Recommended Features)
- Vendor provided Evidera with screenshots of the EXACT and Evidera approved the screenshots based on:
 - Screenshot text is legible
 - Complete, correct EXACT text is included with instructions sentence, 14 items, and copyright statement
 - Screenshot text fits on screen with no breaks/gaps
 - Item and response options fit on 1 screen
 - Clear differentiation between response options
 - \circ Screen titles: Question x of 14
 - Item and response options are left justified
 - Font size is consistent throughout the diary
- Vendor provided Evidera with system requirements for the EXACT and Evidera approved the requirements based on:
 - o Patient bedtime can be entered and updated as needed
 - Diary entry begins on the same day of setting bedtime
 - Completion window around patient bedtime (recommend \pm 3 hours)
 - o Diary is available to patient during specified window
 - Diary is not accessible to patient outside of specified window
 - Message indicating when the patient is out of the window to complete diary.
 - Diary can be completed only once for each (study) day
 - o Message indicating diary has already been completed or diary not available
 - Diary begun just prior to completion window closeout can complete that day's entry
 - \circ An alarm before bedtime (recommend 1 hour)
 - An alarm at bedtime if diary not completed yet
 - An alarm post-bedtime if diary not completed yet (recommend 1 hour)
 - Welcome screen appears at diary activation
 - Patient-specific Access Code (PIN) required to access diary
 - o Only specified number of password or pin code characters accepted
 - Only specified characters accepted (i.e. numerals, alphabet)
 - Instruction sentence is included at beginning of diary
 - Complete, correct text of the EXACT is included
 - Correct Copyright screen is included
 - One item per screen
 - Response options present on the same screen as the item



EXACT e-Diary Certification Program

- Smooth transitions between items
- 0 Selecting "Next" or equivalent command moves to the next question sequentially
- Selecting "Back" or equivalent command returns to the previous question 0
- Skipping questions is not permitted 0
- Pop-up message or sound indicating a question cannot be skipped 0
- Only one response per question is allowed 0
- Selected response option is visibly selected via radio button, highlighting, etc. 0
- Selected responses saved as patient moves through the diary 0
- Response options can be changed prior to saving or exiting diary. 0
- Selected answers for the entire diary can be reviewed 0
- Selecting "Exit" or equivalent command allows participant to exit diary 0
- Screen idle time after X minutes, returns to log-in window or welcome screen 0 (patient may resume questionnaire where they left off after logging in if time out window has not expired)
- 0 Device time out after X minutes, returns to log-in window or welcome screen (partial completion not saved, patient must start over from beginning)
- Patient data for partial, or incomplete diary entries will not be saved and the 0 entire diary will need to be completed again upon re-accessing the diary
- Daily compliance is tracked and appears at end of diary
- Battery power indicator visible
- Diary entries not accessible once saved
- Patient transmits data (daily preferred) 0
- User Acceptance Testing (UAT) conducted by Evidera and all of the above confirmed
